Wall Mural Competition

Rudy's Strudel & Bakery and Polish Village in Parma Ohio is proud to announce the future installation of a wall mural at Rudy's Strudel & Bakery located at 5580 Ridge Rd. Competition for this mural is open to the public with no residency requirements. The completed 15 x 15 foot mural will be prominently displayed on the north wall of the bakery, and will be very visible to southbound traffic on Ridge Rd. Sherba Industries of Brunswick will be installing the mural. Artists are asked to submit a 22.5 x 22.5 inch color completed rendition of the mural for judging. The selected artwork will be copied and enlarged to create the mural to be installed. The artist need not be present for the mural installation.

- Your submission will be reviewed to determine if artwork meets the criteria prior to judging. The committee of five, to be announced at a later date, will select three finalists. The winner will be determined by representatives of Rudy's Strudel & Bakery. Judges decision is final.
- The City of Parma and/or owner of the building the mural will be located on, reserves the right to remove the artwork, by any means necessary at a future date.
- Winning mural artist will be asked to appear for publicity on/or during the unveiling. The winning contestant will receive information prior to that date.
- Contestants agree to allow the Rudy's Strudel & Bakery, Polish Village CDC, and the City of Parma to reserve the right to use the artwork or images of the artwork, taken during or in connection with this event, as well as the artists names and/or likenesses, including but not limited to the use on websites, other social media outlets, print and television media. By submitting your artwork you are granting the right to use it for marketing purposes.
- The winning contestant will receive a cash stipend in the amount of \$500.00. The winning artist relinquishes all rights to the mural image.
- The chosen artist may be asked to alter, add or subtract, elements to the finished work.
- Content should be appropriate for public use. No political, religious, sexual or obscene material will be accepted.

Color entry of proposed finished work must be on a thin substance measuring 22.5 x 22.5 inches. Color and detail is paramount considering this version will be enlarged to produce the finished mural.

Inspirational information includes: old world feel, wheat fields, poppies, Polish tradition, celebrations, family values, bread of life, pastries, and baked goods. These items are strictly inspirational ideas and are not required inclusions to the artwork.

Color and detail is paramount considering this version will be enlarged to produce the finished product. The brighter the color palate the better. Please sign your work.
2. On a separate sheet of paper, briefly describe your work. You may include what inspired you and details of the techniques used, and list the materials used.
3. On a separate sheet of paper provide us with your background, bio or resume. Tell us about yourself. If applicable, describe community involvement.
4. If applicant wishes submitted materials returned, please include proper packaging and postage or we will be unable to return it to you.
